## **Chamber Changes**

- The chamber will ask other organizations to manage events, and the chamber will serve as a partner to provide financial and marketing support where appropriate. Some events may be discontinued if there is not enough interest. Currently the priorities will be 4<sup>th</sup> of July, Christmas, and chamber giveaway drawings.
- The chamber will focus on promoting members, business, and community through social media, digital, and print marketing. The budget will be revised to direct more member dues toward this goal.
