

Hooker Chamber of Commerce Thursday, March 4, 2021

The Hooker Chamber of Commerce membership luncheon was held on Thursday, March 4 at 12 noon at the Hooker Community Center. Present. Lunch was available from Pizza On Broadway. Present were Laneta Adams, Craig Adams, Mary Beth Puyear, Brenda Romero, Rowdy McBee, Velma Smothermon, Buddy Holbert, Linda Brown, Susie Zuniga, Juliann Graham, Maribel Esquivel and Sheila Blankenship.

Mary Beth called the meeting to order and those present were offered a \$5 lunch from Pizza On Broadway. The minutes had been emailed to all members. Brenda made the motion to approve the minutes, Velma seconded and the motion passed.

Craig presented the treasurer report noting a balance of \$15,497.90 with some \$5,000 in membership dues. Mary Beth added that 27 past members have not renewed for 2021 so letters will be sent. Susie made the motion to approve the report, Brenda seconded and the motion seconded.

Mary Beth presented an overview of the 2021 budget. She added that there were several past funds that will not be available this year including the TSET membership so she budgeted less with emphasis on the centennial celebration in June. The Hooker Economic Development Committee has donated \$3,000 toward the centennial celebration. Craig made the motion to approve the budget, Velma seconded and the motion passed.

Mary Beth had asked HALO members to take charge of the March 27 Easter egg hunt but that is the HHS prom so we need volunteers to help. Last year Walmart donated plastic eggs and she has people to fill the eggs with candy but we need people at the city park for the hunt. It was agreed to follow the 2019 event with three age categories for hunting eggs and games: up to kindergarten, first through third grade and fourth through sixth grade. The hunt, featuring three "prize" eggs in each category will begin at 1 p.m. and then it is hoped games or activities will be offered. If possible, the Easter Bunny will be invited to attend.

She also suggested an Easter basket giveaway to involve local businesses. It was decided to ask members who wish to contribute to the prize basket to deliver items to Brenda at the bank and the drawing will be held at the egg hunt. Businesses will receive boxes for their drawing tickets on Monday, March 22 and the tickets will be picked up Friday, March 26. Juliann Graham noted that TCEC will also publicize the event in their employee newsletter.

Mary Beth welcomed the newest members of the Chamber and asked for suggestions for the centennial celebration in June. Promotions include ads on the radio. Cost will be basically be covered by the Economic Development donation will cover. Promotions will also include newspaper ads and possibly some social media ads. Maybe we can offer extended radio ads if businesses want to pay for the long spots. We could offer weekly prize drawings leading up to the June 26 banquet downtown. The meal will be by pre-sold tickets only and will include a featured performer meet and greet, but entertainment afterward that night will be free to all and include local vocalists plus a full free concert sponsored by the Hooker Economic Development Committee. It was suggested to ask Aaron Witt to do another business video so we will have the one from February 2020 and a new one to cover most merchants and show downtown. It is possible we can offer a junkfest earlier in the day downtown and also have the Lions' Club kiddie rides and the Ekkel train. Various promotional items were discussed including t-shirts with a new centennial logo.

Juliann Graham and Maribel Esquivel of TCEC offered information about the new Operation Round-Up program which collects change from member customer bills and donates the funds to various non-profit organizations. Juliann explained the process for groups to request a Round-Up grant. She discussed the independent TCEC Foundation which handles the funds. The program expresses the Cooperative goal, Concern for Community. They expect to earn some \$8,000 a month so funds add up quickly and the next meeting is April 14 to consider applications. Groups may receive up to \$5,000 in Round-Up grants. 100% of funds will remain in the TCEC service territory to community based organizations that serve their towns. The program is based on similar programs of cooperatives for 30 years. The Foundation board meets quarterly but can also meet on an emergency basis to address grants. Juliann reviewed the simple application available on-line.

Buddy made the motion to adjourn, Brenda seconded and the motion passed.

Sheila Blankenship Secretary
